Update From the **Chairman**

Dear Participants,

As of this writing, we are in the midst of recovering from one of the worst natural disasters the Houston area, and the nation, has experienced – Hurricane Harvey. More than 80 Texans lost their lives as a result of the storm, and tens of thousands of Houstonians' homes and property were damaged or destroyed.

Even if you were not directly affected by Harvey, you likely know a family member, friend, neighbor or colleague who was. Our hearts go out to all the people who lost loved ones as a result of this tragic storm. We also want to recognize the countless heroes, many of whom are HMEPS members, who put themselves in harm's way to rescue flood victims, and those who volunteered their time and expertise to provide affected Houstonians with food, shelter and assistance in the recovery process. We know that the road to recovery will be long and difficult, but I am confident Houston will come back stronger in the long run.

Despite the devastation of Harvey, HMEPS was able to process all payments for participants during August, and our staff is working hard to ensure that all transactions are timely and unaffected by the storm. This is a good opportunity for those of you who are not yet receiving pension payments by direct deposit to sign up for the program so that the effect of bad weather on the postal system doesn't delay your receipt of a benefit. Through November 30, 2017, retired DROP participants may request additional partial DROP withdrawals without the usual 90-day waiting period. Please contact your benefit counselor for more details.

HMEPS Recommends Direct Deposit of Your Pension Benefit

HMEPS strongly recommends that you sign up for Direct Deposit when you retire, so your checks will be electronically deposited to your account in your financial institution. Direct Deposit enrollment forms are available from the HMEPS office or you can download them directly from the Retirees section of the


website (www.hmeps.org/retirees). HMEPS must be kept informed in writing of any changes in your home address after you retire, even if you use Direct Deposit, so periodic statements, news updates, and your form 1099-R can be mailed to you.

Harvey and Its Aftermath

The first major hurricane (Category 3 or above) to make landfall in the US since 2005 did everything it could to make up for the previous 12 years. In six days, Harvey dropped 27 trillion gallons of water in Texas and Louisiana, with Houston getting more than its fair share.

If you were lucky enough to escape major damage, now might be a good time to think about your disaster preparation strategy. Of course, it is inevitable that many things will be out of your control regarding situations like this. But there are things you do control, and some of them can make an important difference in critical moments.

Here are just a few items that you might want to consider or make note of.

- Many Houston area post offices were knocked out of action by the storm. Do you want to depend on the post office for the delivery of your pension check? If you haven't already done so, sign up for direct deposit of your pension payments.
- Do you know the elevation of your house, and how it compares to nearby landmarks? The website www.elevationmap.net is useful to make these determinations.
- You can monitor the status of nearby watersheds in Harris County through the website <u>www.</u> <u>harriscountyfws.org</u>. For other metro area counties, information is available in the online version of this newsletter at www.hmeps.org.
- Detailed information on road closures is available at: www.drivetexas.org.
- Centerpoint Energy has an "outage tracker" showing exactly where there are current power

outages within their service area: http://gis.centerpointenergy.com/outagetracker/?WT.ac=OC_Image_Callout.

- What's going on in your neighborhood? You might want to look into the private social network "Nextdoor." (www.nextdoor.com). It won't be much help if you don't have cellphone service, of course. But in my neighborhood this app was very valuable in monitoring which parts of the neighborhood were getting flooded, and which were still dry. I used it in conjunction with the elevation maps mentioned above. There was also other helpful information such as which grocery stores were well stocked, or which restaurants were open.
- Of course, situations like Harvey spawn numerous rumors – many of which get repeated on social media. FEMA has a set up website called "Rumor Central" which can be helpful regarding rumors and common scams that they are aware of: https://www.fema.gov/disaster/4332/updates/rumor-control.
- Finally, while you have been busy recovering from the storm, you may have missed the news that personal information about over 140 million Americans may have been stolen from the credit rating agency Equifax. Was your information compromised? Social security expert Laurence Kotlikoff is concerned that this breach could create problems for current and future social security recipients (https://www.forbes.com/sites/kotlikoff/2017/09/10/has-equifax-just-jeopardized-your-and-143-million-other-americans-social-security-benefits/#460416f56f58). For example, could someone with information stolen from Equifax use


The Retirements section lists names and departments of those retiring participants who have indicated on their retirement applications that they wished to have an announcement of their retirement included.

Pension Payment Schedule, October 2017 - January 2018

This schedule indicates the dates set for payment of benefits. Direct Deposits (ACH) will be deposited on the last business day of each month. If you receive a pension check by mail, it is typically mailed 3-4 days before the last business day of the month. However, postal delays may lengthen the period of time before check delivery.
